

# Connecting the BOSS TONE STUDIO iOS App to the GT-1000 Unit

## 1. Power-on the GT-1000 unit and the mobile device.

- \* Before you continue, turn on the Bluetooth switch of the GT-1000. Make this setting in [MENU] → "HARDWARE SETTING" → "OTHER." (With the factory settings, this is off.)

## 2. In your mobile device's settings, turn Bluetooth on.



### NOTE

Even if "GT-1000 MIDI" is shown in the "DEVICES" list, don't tap it.

## 3. Start the "BOSS TONE STUDIO for GT-1000" app that you installed in your mobile device.

The "Terms of Use" screen is shown.

This screen only appears when the app launches for the first time.

## TERMS OF USE

### BTS for GT-1000 Terms of Use

BTS for GT-1000 (the "App") is an application software licensed for use by Roland Corporation ("The Company") for editing, saving and sharing the settings and memory of GT-1000. All users of this app (hereinafter referred to as "Customers") are deemed to have accepted these terms and conditions upon such Customer's first use of the App. These Terms of Use also apply to the updated application software when the App is updated.

These Terms of Use apply to Customers and the Company, and the Customer is deemed to have agreed to the Terms of Use of the App, the terms of the Roland Cloud End-User License Agreement and the terms of use of the other products and services provided by the Company on the App, together with the terms of the use of <https://www.roland.com/cloud/policies> and other products and services provided by the Company on the App, collectively referred to as the "Individual Terms of Use". In the event the contents of these Terms of Use are different from those of the Individual Terms of Use, these Terms of Use shall prevail.

The Company may change these Terms of Use without the consent of the Customer, at the sole discretion of the Company. In the event of such a change, the conditions of use of this application shall be based on the revised Terms of Use. The Company shall provide such changes to the Customer in advance by posting them on the Application or by any other means deemed appropriate by the Company. The contents of the revised Terms of Use shall apply from the date the Customer commences use of App after such change.

In the event the Customer uses the App after a change in the Terms and Conditions of Use becomes effective, the Customer shall be deemed to have agreed to all the contents of the revised Terms and Conditions of Use.

#### Article 1 (Contents of this App)

This application is a software application that provides GT-1000 settings/memory editing, saving, and sharing functions.

#### Article 2 (Attribution and licensing of rights)

Rights in this application belong to either the Company or to third parties who have granted rights to the Company. The Company grants you the non-exclusive, non-transferable right to install the App on any terminal equipment you own and use the App in accordance with these Terms of Use.

#### Article 3 (Prohibitions)

The Company prohibits you from doing any of the following, except as expressly granted in these Terms of Use or on the App:

- (1) Reproduce, process or alter, transfer, make transmittable, rent, sale, redistribute, or sublicense the App in whole or in part to allow any third party to use it;
- (2) Infringe any intellectual property rights (including, without limitation, copyrights, design rights, patent rights, utility model rights, trademark rights, publicity rights, privacy rights, moral rights, etc.) or any other proprietary rights or profits of the Company or any third party;
- (3) Analyzing or modifying the App by reverse assembling, reverse compiling, or reverse engineering, etc;
- (4) Use of the App by a minor, an adult ward, a person under conservatorship, without the consent of a statutory agent, guardian, curator, assistant;
- (5) An act of a person judged by the Company to be an anti-social force, including, without limitation, an organized crime group, a company affiliated with an organized crime group, or any entity advocating for violence or hatred towards any group, or a member or facilitator of any entity cooperating with or engaging in the anti-social force using this application;
- (6) Acts that interfere with the operation or network system of the App;
- (7) Acts contrary to laws and regulations, public order and morals, or acts contrary to ordinary common sense as adjudged solely by the Company;
- (8) Acts in breach of these Terms of Use, the Individual Terms of Use, and other precautions stipulated by the

**4. Click "ACCEPT" to agree to the contents after you've read them.**

**5. Tap [Bluetooth MIDI DEVICE] that appears in the screen, and then tap "GT-1000."**


### STEP 2

Tap the Bluetooth MIDI Device button below and select the device to pair from the list.

#### PAIRING

Bluetooth MIDI DEVICE


- \* If you changed the Bluetooth ID (p. 8), the changed number is shown following "GT-1000." If "Bluetooth Pairing Request" appears, tap "Pair."



Verify that "Connected" is shown.

6. Tap [**<Back**] to return to the previous screen.
7. Verify that "GT-1000 MIDI (Bluetooth)" is shown for "CONNECT."



8. Tap [**OK**] to start communication.

## If you can't connect

Check each of the following five items one at a time.

- 1 In the settings of the GT-1000 unit, is the Bluetooth function turned on?**

Verify that the GT-1000 unit's Bluetooth indicator is blinking or lit.

If it is unlit, press the [Bluetooth] button to make it blink or light.

- 2 In step 2 of the procedure (p. 2), could you have tapped a model name shown on the mobile device?**

When you turn the Bluetooth switch on in step 2, "GT-1000 MIDI" might appear in the list of "DEVICES" but you should not tap it. If you tapped it, clear the pairing, and try the procedure again from step 1.

# Clearing the pairing

1. Tap the "i" located beside "Connected," and then "Forget This Device."



2. Turn the Bluetooth switch off.



3. Turn Bluetooth on and off once again

Turn Bluetooth on/off again.

#### **4** Close all apps, and try the procedure again from step 1 (p. 2)

If you've checked **1**–**3** and still cannot connect to the app, close all apps that are running on your mobile device.

If the GT-1000 is paired, clear the pairing.

### Closing the app

Double-click the home button, and swipe up on the app screen.

- \* If you're using the iPhone X, the procedure for closing an app is different. Close the app as appropriate for the iPhone X.

#### **5** Power-off the mobile device and the GT-1000 unit, and then power them on again

If you've checked **1**–**4** and still cannot connect to the app, power-off the mobile device and the GT-1000, wait for about 10 seconds, and power them on again.

If the GT-1000 is paired, clear the pairing.

If you've checked **1**–**5** and still cannot connect to the app, contact your dealer or a Roland customer service center.

## Changing the Bluetooth ID

Here's how you can specify "1" as the Bluetooth ID.

- 1. Press the GT-1000's MENU button.**
- 2. Choose "HARDWARE SETTING."**
- 3. Choose "OTHER".**
- 4. Change the Bluetooth ID parameter.**

Value: OFF, 1–9

If the setting was made correctly, the Bluetooth MIDI DEVICE screen of BOSS TONE STUDIO indicates "GT-1000\_1." If, after specifying the number "1" or 2, you want to return to a state in which nothing is specified, set the parameter to "OFF."
